In addition, your firm will continue to be identified as a certified firm in the MTA Directory of Certified Firms.

Your firm's certification status with the MTA is effective for three years from the date of this letter, provided there are no changes in disadvantaged status, ownership, control and/or operations of the firm or eligibility requirements during the approval period. However, during this three-year period you are required to submit annually, on the anniversary date of this notice, a sworn notarized affidavit affirming whether there have been any changes in your firm's disadvantaged status, ownership, control or operations, along with supporting documentation. You are also required to submit a Statement of Personal Net Worth and supporting documentation annually. Please note that you must immediately notify the MTA Office of Civil Rights, Division of Business Programs,


of any changes in your disadvantaged status, ownership, control and/or operations including business services and capabilities within 30 days of change.

Failure to properly notify the MTA Office of Civil Rights, Division of Business Programs of these changes may result in commencement of action to remove your firm's certification.

The MTA Office of Civil Rights, Division of Business Programs, reserves the right to re-evaluate a business' certification eligibility prior to the firm's participation on a MTAHQ, MTA New York City Transit, MTA Long Island Rail Road, MTA Metro-North Railroad, MTA Long Island Bus, MTA Bridges and Tunnels or MTA Capital Construction Company federally assisted projects or anytime that they determine that such re-evaluation is warranted.
